About TEF

ORGANIZATION

- Mission: empower people by increasing access to transit options
- Est. 2011 "Basic Transportation Needs Fund" with an allocation from CapMetro
- Independent volunteer board

PROGRAMS

- Microgrants (\$1,000) to meet short-term transit needs
- Transit passes for partner organizations are deeply discounted (approx. 80% reduction)
- Demonstration (\$50,000-\$75,000) and planning (\$25,000) grants to test innovative mobility solutions

PURPOSE

Identify potential projects participants want to work on together to address current challenges or opportunities for meeting senior mobility needs, specifically demonstration or planning projects that TEF can consider for funding.







Increased need and demand for services



More focus on fixed route rides/group rides versus individual rides



More strain on volunteer base



Increased use of rideshare or paid drivers

Improved use of technology (i.e. GPS systems, dispatch)

- Convene, connect and move to action
- Disperse some funds for pilot
- Fund a technology solution for connecting, i.e. dispatch
- Gather information from seniors on how they see the barriers
- Connect service providers together; one organization that covers region
- Find ways to subsidize rides for more free or low cost options i.e. vouchers



Generating Project Ideas

TEF Planning & Demonstration Projects

Mechanism for piloting innovative transit-supportive projects that:

- Address a demonstrated need in the community;
- Leverage existing resources or partnerships efficiently;
- Support or leverage environmentally efficient modes of transportation such as shared rides, public transit, or active modes;
 and
- Could be sustained through follow-on funding after the demonstration period.

Funding Details

Planning Projects

Up to \$25,000 per award

One-year award to develop a plan or project that addresses a specific challenge.

Demonstration Projects

Between \$50,000 and \$75,000 per award

Multi-year award to launch, run, and evaluate a program or service.

Recent TEF Demonstration Projects

2021 Capital Area Private Defender Service

Rides for Reentry Program

Connect individuals exiting incarceration with transportation support, primarily rideshare, to access court appointments and resources

2022 Jail to Jobs

Georgian Acres Smart Mobility Hub

Provide free wifi, solar panel lighting, covered seating, charging stations for e-scooters and e-bikes, and shuttle rides to community members as a first-mile / last-mile transportation solution.

2022 United Way

Transportation for Living Pilot

Test a responsive, sustainable, scalable subsidized transportation system to provide more transportation options to a variety of destinations for older, transit-dependent adults in Travis County

Convening Purpose:

"Identify potential projects participants want to work on together to address current challenges or opportunities for meeting senior mobility needs, **specifically** demonstration or planning projects that TEF can consider for funding."

TRANSIT EMPOWERMENT FUND

Process

- 1. Choose a Group
- Brainstorm Possible Project Ideas Consider both short-term or longer-term ideas
 10 Minutes
- 3. Cluster & Label Ideas Generate a short phrase or sentence that captures the essence of clusters of ideas 10 Minutes
- 4. Select a Project Idea to Develop Further Choose an idea that has the most energy and create a rough draft of a "pitch" for a possible project for funding 15 minutes
 - Be thinking about who, what, where, when, how
- Report out Have a volunteer report out the project pitch to group

 3 minutes each

Action Steps



Process

- 1. Is there a particular idea you'd like to work on? Join that Group!
- 2. In small groups, start doing some preliminary action planning to further develop idea for TEF consideration by June.
- 3. Complete worksheet to flesh out initial action steps:
 - Action
 - First Step
 - By Whom
 - By When
 - Resources / support needed
